

PRIVACY POLICY

Preamble

“The GDCC Bank Ltd”, or “The Gadchiroli District Central Cooperative Bank Ltd” or “Bank” means “The Gadchiroli District Central Cooperative Bank Ltd.” having its Registered under The Maharashtra Co-operative Societies Act, 1960 under registration No. RPCD.Nag.DCCB/L/10 of 05/03/2012 and having its registered office at Head Office, The Gadchiroli District Central Cooperative Bank Ltd, Near Bus Stop, Dhanora Road, Gadchiroli – 442605.

This Mobile Privacy Policy (“Policy”) applied to users of mobile banking through “The GDCC Bank Ltd” The term “The Gadchiroli District Central Cooperative Bank Ltd” or “The GDCC Bank Ltd” or “we”, ”us” or “our” in any mobile banking application we own and control and in this Policy refers to The Gadchiroli District Central Cooperative Bank Ltd. and our affiliates or subsidiaries. This Policy describes how the MPassbook application hereafter known as “GDCC MPassbook” or “The GDCC Bank MPassbook” or “MPassbook Application” to collect, use and share information from or about you and explains how the information may be shared or used.

Agreement to Policy

By viewing MPassbook Application or GDCC MPassbook of The Gadchiroli District Central Cooperative Bank Ltd or by using The Gadchiroli District Central Cooperative Bank Ltd website “<http://www.gdccbank.com/>” on a mobile device, you consent to this policy which includes you consent to disclose and use information about you in the manner detailed in this policy. Other privacy policies may also apply in addition to the terms of this Mobile Privacy Policy, including but not limited to our Privacy Policy.

Information Collection, Use or Sharing

Information that we may collect about you through mobile banking includes information that you voluntarily disclose at the time of subscription such as your name, primary a/c number, alias a/c, secondary account number/s, mobile number and other contact information; transaction information, information resulting from your mobile activity in terms of your usage of the subscribed mobile banking service. We do not gather additional information associated with your mobile device through cookies and other technologies. We also do not share any of this information with any other company unless required to do so by law or while handling any disputes that may arise.

Communications

We may use your Personal Information to contact you with newsletters, marketing or promotional materials and other information.

Security

We apply several security measures to protect your information. Reply messages sent by the MPassbook use masking features to hide the first few characters in yours a/c numbers. To help prevent misuse of services and authorize access to your banking information, you are always required to type in

your password provided by the bank or set by you from time to time. As always, we strongly encourage you to assist us in that effort by not sharing your password with anyone. Though the security of your Personal Information is important to us, there is no method of transmission over the Internet, or method of electronic storage, is 100% secure. While we attempt to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
